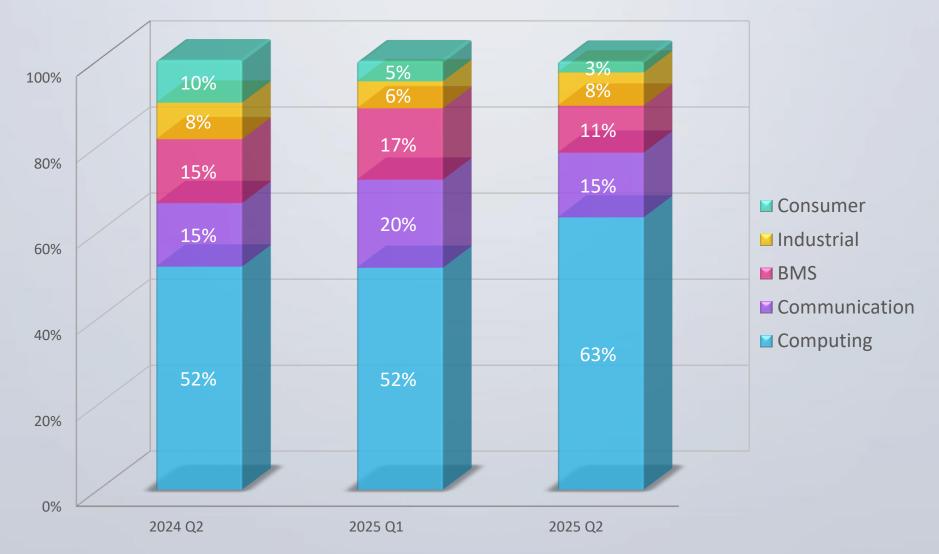

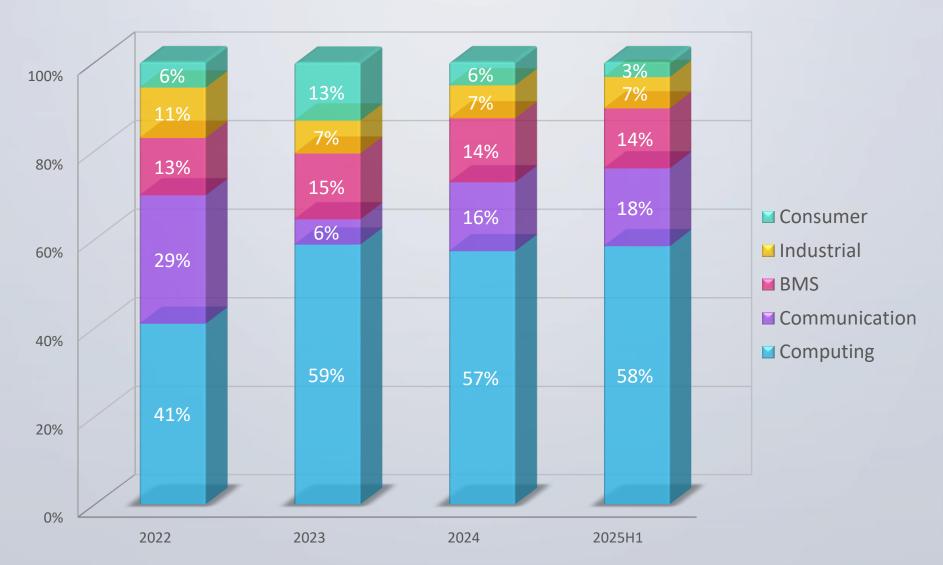








Percentage of revenue by application
